Citizens of certain countries may be eligible to travel to the 2015 ACS National Meeting in Denver under the Visa Waiver Program (VWP). PLEASE NOTE: Every visitor traveling under the VWP must now register under the Electronic System for Travel Authorization (ESTA) 72 hours in advance of travel. Please visit the US State Department Website (http://travel.state.gov/visa/temp/without/without_1990.html) for more information about eligible countries and the new VWP registration procedures.

If your country of residence is different from your country of citizenship or birth, there may be a requirement for additional visa application processing time.

1. This personalized letter for meeting presenters verifies whether your scientific paper has been accepted for presentation at the national meeting through the Meeting Abstracts Programming System (MAPS).

Personal invitations are not necessary to attend meetings of the American Chemical Society. All ACS meetings are open scientific events and welcome all persons who are interested, pay the necessary registration fee, and otherwise conform to ACS Bylaws for its meetings.
3. You can register for the meeting at <http://www.acs.org/meetings> and bring your registration confirmation paperwork to your visa interview. Please note that ACS is not in a position to contact embassies or consulates on your behalf to intervene on visa applications. It is best to be well prepared and initiate your visa application in a timely manner.
